


Phil Carr Presents Flag Certificate


Benjamin Harrison

Born August 20, 1833 in North Bend, Ohio, he was the grandson of President William Henry Harrison. Harrison attended Farmer's College near Cincinnati, Ohio for two years and then transferred to Miami University, in Oxford, Ohio graduating in 1852. On Oct 20,1853 Harrison married Caroline Lavinia Scott, they had two children Russell Benjamin Harrison and Mary Scott Harrison McKee. He enlisted in the Union Army in 1862 as a 2nd Lieutenant when his unit left Indiana he was promoted to Colonel in the 70th Indiana Regiment. He served in the Cumberland Valley, and then under W.T. Sherman participating in a number of battles up to and including the Battle of Atlanta, he would be

transferred to the Nashville Theater before Sherman's March to Savannah. Harrison would be promoted on March 22, 1865 to Brigadier General and would march in the Grand Review at the end of the Civil War. On March 4, 1881 Harrison would be appointed by the Indiana Legislature to U. S. Senator and he would serve in that capacity until March 4, 1887. In 1888 he was chosen as the candidate for the Republican Party on the 8th ballot. He would defeat Grover Cleveland in the election of 1888 and serve as President of the United States until 1893 when he would lose in his reelection bid to Grover Cleveland. In 1896 he remarried his deceased wife's niece Mary Scott Lord Dimmick, 25 years his Junior, they would have 1 child Elizabeth born February 21, 1897. Early in 1901 he contract a heavy cold which turned to Pneumonia, and died on March 31, 1901.

History Fair Winner

At the St. Lucie County History Fair held on the 26th of February, we had our first winner in the last three years. Annually the St. Lucie River Chapter members volunteer to judge the History Fair entries from all the schools in the county, each year it is one of the best things we do. This year Corben Hampe of Southport Middle School made up the project to the right as his presentation to the 2011 St. Lucie County History Fair held this year at Samuel Gaines Middle School in Fort Pierce. There were about 80 projects and all are good, also there are video tape presentations, plays, skits, and music presentations. I would like to say that his project is the first Revolutionary War project in the last


