

Franklin Delano Roosevelt

Franklin Delano Roosevelt, the 32nd President of the United States and possibly one of the most famous of all the Presidents, the only President elected to more then two terms in office, he was elected to 4 terms, dying a short time after beginning his fourth term. FDR as he was known was born January 30, 1882 the only child of James and Sara Ann "Delano" Roosevelt, born to wealth and privilege, he was named for hi Mother"s favorite Uncle, Franklin Delano. Roosevelt would attend Groton School and then Harvard College, graduating in 1903, he would be a member of Alpha Delta Phi Fraternity and was Chief Editor of the "Harvard Crimson". While at Harvard Roosevelt's fifth cousin, Theodore Roosevelt became President, Teddy would become FDR's role model and hero. In 1902 met his future wife, Theodore Roosevelt's niece Eleanor, a fifth cousin once removed. In 1904 Roosevelt entered Columbia Law School, but dropped out after he passed the Bar Exam in 1907. On March 17, 1905 FDR married Eleanor Roosevelt, Theodore Roosevelt walked Eleanor down the aisle as she had lost both parents before she was 10 years old. They



would have six children, Anna Eleanor in 1906, James in 1907, Franklin Jr. in 1909 died young, Elliott in 1910, a second Franklin Jr. in 1914 and John Aspinwall born in 1916. By 1918 FDR and Eleanor had hit a rocky time in their marriage but by 1920 they had resolved their major differences, but Eleanor would always act independently from that point on, living separately on occasion. In 1910 FDR began his political career, being elected to the New York State Senate, then again in 1912 he was elected again. Roosevelt worked hard for Woodrow Wilson and when he was elected President, Roosevelt was rewarded with an appointment as Assistant Secretary of the Navy in 1914 Roosevelt tried for the US Senate but Wilson would not support him and he lost that election. Then in 1920 he was picked to run for the Vice President of the United States on the Democratic Ticket, but he and the Presidential Nominee were soundly thrashed by Warren G. Harding. After this Roosevelt returned to New York and reentered the practice of law. The disaster struck, while vacationing in Campabello, Canada, Roosevelt was struck down by what was called Infantile Paralysis (Polio), today it is suggested that he did not have polio but Gullian-Barre Syndrome, the truth will never be known as his spinal fluid was never tested. By the end of the 1920's FDR was back in politics, running for the Governor of New York, he was elected in 1928 and again in 1930. Roosevelt was by the end of 1931 firmly in control on the Democratic Party and the logical choice to run for President, running on a platform of bashing Hoover and negativity, FDR won all but 6 states and 57% of the vote. Roosevelt won the Great Depression, 24% unemployment, the banking system in complete collapse, and the economy in complete disarray. He would begin the process of redeveloping and redefining the U.S. Government; new programs, a bitter fight with the Supreme Court and bitter battles with the Republicans, and finally the greatest war of all time the Second World War. The New Deal, on March 4, 1933 Roosevelt took over the Presidency in the middle of a banking collapse, he immediately had Congress pass the Glass-Steragle Act that created the F.D.I.C., then formed the Federal Emer\gency Relief Act, which created the CCC the Civilian Conservation Corps. which created 250,00 jobs. (If you go into the National Park System you can still see the effects of these 250,000 jobs, in the infrastructure they built). The N.I.R.A. (National Industrial Recovery Act) which created among other project the largest government owned industrial enterprise in the History of America, the Tennessee Valley Authority. the Supreme Court unanimously ruled it unconstitutional. In 1933 Roosevelt eliminated the ability to own gold by private citizens, he issued an executive order allowing 3..2% beer available, Congress and the American People soon after repealed Prohibition with the 21st Amendment. Roosevelt's 1936 reelection, newer programs were established, W.P.A. Works Progress Administration, which employed 2,000,000 people, the Wagner Act which established federal rights for Unions. Then in 1937 Roosevelt pushed through Social Security, and by 1938 unemployment had been reduced from 24% to 12%. In 1940 Roosevelt following the precedent establish by George Washington, refused to be reelected except by acclimation, at the Convention he was renominated but he missed unanimous support by 100 votes, but he took the nomination anyway, and then in 1941 began the Second World War. Beginning in 1938 Roosevelt began a gradual build up of American Industrial might, Lendlease with Britain supplying the Chinese in their fight against the Japanese all came to an end with the attack on Pearl Harbor, Roosevelt turned the might of the American industrial complex on to destroy the Axis, 4 years later Germany surrendered and shortly after Japan also surrendered. Roosevelt would not live to see the end of WWII, but his efforts would establish him as one of the Unite States greatest Presidents. He would establish a great personal report with Winston Churchill, and Joseph Stalin but after his death Stalin reneged on all deals that had been made beginning the Cold War. On March 29, 1945 Roosevelt was at the Little White House at Warm Springs he complained of a terrific pain in the back of his head and collapsed unconscious, he was carried to his bedroom where his Doctor diagnosed a massive cerebral hemorage and at 3:35 PM he was pronounced dead.


