50/50 Drawing: The \$13.00 was won by Carl Dennis, who donated his winnings to Guy's Duck



## Warren G. Harding

The seventh in the series of Presidents, who have been members of the Sons of the American Revolution. Warren Gamaliel Harding born November 2, 1865 in Blooming Grove, Ohio, the first of eight childrem born to Dr. George T. Harding and Phoebe Elizabeth (Dickerson) Harding. Harding went to rural schools as a child, and in 1875 his father moved to Caledonia, Ohio and purchased *The Argus* a weekly newspaper, there at *The Argus*, Harding at the age of 10 began a life long passion for newspapers. He worked at the *Union Register* while attending college at Ohio Central College, from which he graduated with a Bachelor of Science degree at the age of 17. Harding was an accomplished cornet player and played with a number of bands the best being the Citizens'Cornet Band which he placed third at the prestigious Ohio State Band Festival. Upon graduating Harding tried a number of jobs, teacher, insurance salesman, and tried reading the law but he tired of these quickly, then in partnership with others he raised \$300 and purchased the *Marion Daily and by* 1886 was the sole owner of the *Star*, he was 21. The operation of his newspaper and the stress of competing with others newspapers landed Harding in the hospital suffering from exhaustion and

nervous fatigue. He would end up in this situation 5 times over the next 4 years. On July 8, 1891 Harding married Florence Kling DeWolfe, she was five years older then him and had a young son, she also was the daughter of Harding's fiercest enemy Amos Hall Kling. Harding and Kling would feud until almost 1900 before they reconciled. Harding and his wife were complimentary, Harding with a mild mannered easy personality and his wife with the hard driving no nonsense outlook of her father, together they turned the newspaper into a profitable business. Harding would always call her "Duchess". Through the paper Harding began an interest in politics, running unsuccessfully for Marion County Auditor's Office, then in 1897 he was elected to fill the Ohio State Senate seat for District 13. In 1903 he ran for the Governorship of Ohio but the party had other ideas and he ended up with the Lt. Governor's job where he served from 1904 to 1906. He would try twice more for the Governor's job but failed each time, then in 1912 Harding gave the nominating speech for William Taft. Taft would lose but Harding had made his mark in the Republican Party and in 1915 he would run and win the United States Senate Seat and the first Ohio Senator elected by popular vote. He would hold that seat until 1921 when he resigned the seat to become President of the United States. At the Republican Convention of 1920 Harding began at fourth with only 39 convention votes, after 9 ballots and no consensus had been reached, Harding was put forth as the compromise candidate on the tenth ballot. When he won the nomination on the tenth ballot his wife Florence was so shocked that she accidently stabbed Harding's campaign manager, Harry Daugherty with her hat pins. Harding was asked if he any incidents in his past or the present that would reflect badly on him or the Party and he answered "NO", but shortly thereafter his latest "friend " and her husband where sent on an extended investigation of the silk trade in China until after the election. Harding won the election of 1920 in a landslide, over 60% of the poplar vote; the highest ever recorded and with 404 electorial votes. The Harding Administration would be wracked by controversy and turmoil, his habit of using political patronage for his friends helped fuel the controversy and the rise of the unions fueled the turmoil. Controversy would come from the green house on "K" Street, political appointees from Ohio called the Ohio Gang, the Tea Pot Dome Scandal where the Secretary of the Interior was arrested and jailed for taking bribes. The turmoil from the unions reached it's zenith with the Blair Mountain miner war, where over 150 people were killed in pitched battles between United Mine Workers and private militia's controlled by the Coal Company, this was finally put down by sending in the US Army; the great railway strike that erupted in 1922 and it took the National Guard and 2200 Deputy US Marshals to keep the 400,000 union workers and private company militias apart. But not all was bad, the Veterans Bureau and the Bureau of the Budget were established, an 8 hours federally mandated work day was created, huge arms control deals were worked out and the Sheppard -Towner Maternity Act was created so that 3000 child and health centers were established. The in June of 1923 President Harding decided to make a grand tour, "a voyage of understanding", where the president and his group would tour the western United States and Alaska, a physically demanding trip with speeches and stops. As the trip proceeded Harding's health began to deteriorate and then in Vancouver, Canada on the 26th of July he complained of nausea and upper abdominal pain, he was given digitalis. Harding met with Canadian Officials and inspected the Vancouver Regiment honor guard, he went on to Seattle where he gave a speech, not even waiting for applause, then to Portland, Oregon where his scheduled speech was canceled and then to San Francisco where on August 2, 1923 at 7:35 PM while lying in bed talking with his wife, Harding shuddered and died. Controversy did not end there, because of Mrs. Harding's refusal to have an autopsy rumors came forth that she had poisoned him or he had committed suicide, but he had been showing signs of congestive heart failure for months, and doctors stated that he had died of a heart attack. Mrs. Harding returned to Washington with her husband's body and then stayed with President and Mrs. Coolidge in the Whitehouse for a month, during her stay she collected all of her husband's papers and had them destroyed, then she returned to Ohio and did the same, only 1/7 of his personal papers remain to this day and they are not open to the public. Mrs Harding died 21 November 1924, she and her husband are buried in the Harding Presidential Memorial, Marion Ohio.
