

## **Port Saint Lucie State VA Home**

On September 23, Governor Rick Scott approved building Florida's seventh veterans nursing home on a 28.5-acre site in Tradition in St. Lucie County. The 120 bed facility will employ 190 people while serving the needs of area veterans.

The Saint Lucie River Chapter, FLSSAR, was proud to be represented at the Awards Recognition Gala held on October 14th celebrating the VA home's approval. Dignitaries included St. Lucie County Commissioner Franny Hutchinson, who served as moderator, U.S. Congressman Patrick Murphy, Florida State Senator Joe Negron, Florida Representatives Gayle Harrell and Larry Lee, Jr., St. Lucie County Sheriff Ken Mascara, Port St. Lucie Mayor JoAnn Faieilla, as well as many other county and city dignitaries.

Also present were Florida VA Deputy Executive Director Al Carter, St. Lucie County Veterans Services Manager Wayne Teegardin, as well as several military veterans groups including the Vietnam Veterans Group, American Legion, Military Officers Association, The Color Guard was represented by Jack Ivy Marine Corps League Detachment #666 Commandant Mike Ambrosia.

Chapter members were able to meet several attendees and discussed our help to the Veterans in our area. The Liberty Tree (1646–1775) was a famous elm tree that stood in Boston near Boston Common, in the days before the American Revolution (1776-1783). In 1765, colonists in Boston staged the first act of defiance against the British government at the tree. The tree became a rallying point for the growing resistance to the rule of Britain over the American colonies and for that reason it was felled by British soldiers in 1775.

In 1765 the British government imposed a Stamp Act on the American colonies. It required all legal documents, permits, commercial contracts, newspapers, pamphlets, and playing cards in the American colonies to carry a tax stamp. Because the Act applied to papers, newspapers, advertisements, and other publications and legal documents, it was viewed by the colonists as a means of censorship, or a "knowledge tax," on the rights of the colonists to write and read freely.

On 14 August 1765, a crowd gathered in Boston under a large elm tree at the corner of Essex Street and Washington Street, originally called Orange Street, to protest the hated Stamp Act. Patriots who later called themselves the Sons of Liberty had hung in effigy Andrew Oliver, the colonist chosen by King George III to impose the Stamp Act, in the branches of the tree. Up in the tree with the effigy hung a British cavalry jackboot. Grinning from inside the boot was a devil-like doll holding a scroll marked "Stamp Act." It was the first public show of defiance against the Crown and spawned the resistance that led to the American Revolutionary War 10 years later. On 10 September, a sign saving "Tree of Liberty" was nailed to the trunk of the tree.

In the years leading up to the war, the British made the Liberty Tree an object of ridicule. British soldiers tarred and feathered a man named Thomas Ditson, and forced him to march in front of the tree. During the siege of Boston, a party of Loyalists led by Job Williams defiantly cut

the tree down in an act of spite, knowing what it represented to the colonists, and used the tree for firewood. This act only further enraged the colonists. As resistance to the British grew, flags bearing a representation of the Liberty Tree were flown to symbolize the unwavering spirit of liberty. These flags were later a common sight during the battles of the American Revolution.

For many years the remnant of the tree was used as a reference point by local citizens, similar to the Boston Stone, and became known as the "Liberty Stump." Later the citizens in many of the colonies erected a Liberty pole in commemoration of the Liberty Tree.

Besides actual trees, the term "Tree of Liberty" is associated with Thomas Jefferson's quotation, "The tree of liberty must be refreshed from time to time with the blood of patriots and tyrants."

#### To William S. Smith Paris, Nov. 13, 1787

#### DEAR SIR,

-- (...) Wonderful is the effect of impudent & persevering lying. The British ministry have so long hired their gazetteers to repeat and model into every form lies about our being in anarchy, that the world has at length believed them, the English nation has believed them, the ministers themselves have come to believe them, & what is more wonderful, we have believed them ourselves. Yet where does this anarchy exist? Where did it ever exist, except in the single instance of Massachusetts? And can history produce an instance of rebellion so honourably conducted? I say nothing of it's motives. They were founded in ignorance, not wickedness. God forbid we should ever be 20 years without such a rebellion. The people cannot be all, & always, well informed. The part which is wrong will be discontented in proportion to the importance of the facts they misconceive. If they remain quiet under such misconceptions it is a lethargy, the forerunner of death to the public liberty.

We have had 13. states independent 11. years. There has been one rebellion. That comes to one rebellion in a century & a half for each state. What country before ever existed a century & half without a rebellion? & what country can preserve it's liberties if their rulers are not warned from time to time that their people preserve the spirit of resistance? Let them take arms. The remedy is to set them right as to facts, pardon & pacify them. What signify a few lives lost in a century or two? The tree of liberty must be refreshed from time to time with the blood of patriots & tyrants. It is it's natural manure. Our Convention has been too much impressed by the insurrection of Massachusetts: and in the spur of the moment they are setting up a kite to keep the hen-yard in order. I hope in God this article will be rectified before the new constitution is accepted. ( ... )
