Presentations:

Chuck McKinley called Jay Wise, Joe Leinbach and Phil Car to the floor to award Military War Medals to Jack Irvin and Carl Wade; Joe Leinbach read the citations, and Jay Wise and Phil Carr pinned the medals on them. We thought it fitting to have World War II and Korean War veterans do this to show the transition from those to the new Generation of Vietnam and other Veterans. The presentations were then turned over to Carl Wade and Jack Irvin to award the Florida Veterans Battalion Certificates to Chris Wade and Dan Olin. They awarded and pinned Dan Olin's Military Service Medal. Jack and Carl are now responsible for all veterans' recognition activities.

Jay Wise called Scott Van Duzer to the floor and read a letter from Fort Pierce Mayor Linda Hudson to Scott as well as read his Bio. Scott introduced his scout leader Rusty Hines and Joseph Jean and Jocelyn Jocirin who were from the first group of scouts in the troop. Jay then pinned Scott with the Bronze good citizenship medal, followed by Scott speaking of their goal to keep children off the streets and out of gangs in the Fort Pierce Area and how they formed the troop, the successes they have achieved, travel to government National and State facilities, neighborhood cleanup and other civic activities without the children receiving any payment. Scott received several interruptions for applause praising his efforts reducing crime in the Fort Pierce area by getting youth involvement in the community.

The chapter Patriots on Parade (POPS) was initiated today with a presentation by Jay Wise telling us of his patriot, Lt. Colonel Frederick Wise of Pennsylvania. He also provided a copy for the WHIG as that is to be the process also. Additionally, Edna Schubert gave a presentation on the Glenn's Patriot George Holter and other ancestors of late husband, former member Glenn Schubert. All presentations were well received by the audience. Edna provided her copy for the Whig as well.

Information and News:

Wreaths across America:

An overview was given by Chuck McKinley and a motion was brought before the Chapter for approval of a Chapter donation to the fund. A motion to approve \$100 from the chapter was brought forward by Jack Irvin.

Carl Wade seconded the Motion and a vote was held with all in agreement by the members present. Jay Wise took up a collection from the meeting attendees and collected a total of \$185. In summary Chris Wade will prepare a total check from the chapter donation and the collected moneys so in essence there will be \$285 AVAILABLE FOR THE DONATION TO THE Wreaths across America program in our area.

Membership Committee Report

John Sheppard provided an update of membership activities since the last meeting;

1 application approved at National; 1 supplemental pending at National; 3 applications pending at State; 5 applications completed, waiting for checks so they can be mailed to State.

John read NSSAR's "Acceptable Service by a Patriot Ancestor", listing all the services of Patriots that can be used by applicants for membership. . This useful document can be used during recruiting and in schools for history presentations.

He also mentioned that soldiers in the Battle at Point Pleasant, West Virginia are considered Revolutionary War Patriots by both the SAR and the DAR, even though the battle took place in the year before the Battle of Lexington. He is in the process of gathering more information for a presentation in the future.

Veterans Affairs Committee- Jack Irving discussed his attendance at the South Fork Middle School in the Saint Lucie County School Districted where he joined several veterans speaking to students about the historical aspects of the American Revolution.

We made an announcement for our annual Food Drive for members to bring items to the December meeting. Further details will appear the Whig.

Attendees were also asked to participate in Veterans Day Activities in Stuart and Port Saint Lucie.

We solicited a request for support at the next Farmers Market Recruiting drive on the 15th. Jay Wise will be out of town for this month effort.

Guys Duck netted \$16 and was conducted by Joseph Jean, one of the scouts from Scott Van Duzer's Troop 772.

## Major General Henry Knox

Henry Knox was born in Boston in 1750. His father was a shipmaster trading with the West Indies who died at the age of fifty. Henry gave up school to support his mother. Taking a job at a Boston bookstore, he became avid reader of history. Eventually he opened his own bookstore.

In 1772, Knox co-founded the Boston Grenadier Corps. He volunteered at the Battle of Bunker Hill in June 1775, serving under General Ward. In July, General George Washington arrived and was impressed by Knox. Washington was considering the need for artillery in the American forces and found Knox to be knowledgeable on the subject, a result of his extensive reading and recent experience. Washington asked Knox's opinion on the subject. Knox thought to use the cannon recently captured from Fort Ticonderoga and was given the difficult task of bringing those cannon to Boston. He was commissioned a Colonel and placed in charge of artillery. Knox successfully brought the cannon to Boston by ox sleds and other various means. Knox eventually placed these cannon on Dorchester Heights. Seeing this, British General Howe removed his troops from Boston before the impending bombardment. Americans entered the town the following day.

Knox then superintended the defenses of Connecticut, Rhode Island, and New York City.

Knox was with the Army during the New York and New Jersey campaign. He handled logistics for crossing the Delaware River preparatory to the Battle of Trenton on December 26, 1776. For his service, Knox was promoted to Brigadier General and given command of an artillery corps consisting of five regiments. Knox was at the Battle of Assunpink Creek and at Princeton.

With the Army in Winter quarters, Knox went to Massachusetts to improve the Army's artillery manufacturing capabilities.

He raised a battalion of artillerymen and established an armory at Springfield, Massachusetts before returning to the Army in the Spring.

In June 1777, Henry Knox learned of Congress's appointment of Philippe Charles Tronson du Coudray to command the artillery. Knox threatened resignation. Du Coudray was a French soldier of fortune whose appointment upset not only Knox but John Sullivan and Nathanael Greene as well. Du Coudray was reassigned as Inspector General and died in September from a fall.

Knox was with the Army at Brandywine and Germantown, where his suggestion to take a particularly strong British defensive position rather than bypass it proved to delay the army's advance and allow the British to reform their lines. Knox was present at the Battle of Monmouth, where Washington commended his artillery performance.

Knox and his artillery wintered in Pluckemin, New Jersey, where Knox established a school of artillery and officer training, becoming a precursor to the United States Military Academy at West Point, New York. Through the Summer of 1779 and beyond, Knox saw to the training of more than 1000 soldiers.

During the following period of relative inaction, Knox served as Washington's representative to Northern states with the purpose of increasing the flow of men and supplies to the army.

In 1781, Knox moved south with the Army and participated in the Siege of Yorktown. He directed the placement and aiming of artillery, and was considered intelligent and active. Washington commended both Knox and the French artillery chief for their actions, and recommended Knox for promotion, which was granted March 22, 1782. Knox became the army's youngest Major General.

In August 1782, Knox became commander of the facilities at West Point.

In April 1783, Congress began demobilizing the Army, and Washington put Knox in charge of day to day operations. Knox drafted plans for the establishment of a peacetime army, including the establishment of two military academies and bodies of troops to defend the nation's borders. Many of his provisions were implemented. After General George Washington retired, Knox became senior officer of the army.

On March 8, 1785 Congress appointed Knox the second Secretary of War. The army was only a fraction of its former size. Congress authorized a seven hundred man army and Knox stationed the troops on the western frontier. Knox recommended the purchase and stockpiling of weapons at national armories. After the outbreak of the French Revolutionary Wars, Knox urged and presided over the creation of the United States Navy and the establishment of coastal fortifications.

American Indian Wars occupied the remainder of Knox's tenure in office.

On December 28, 1794 Knox tendered his resignation. Knox died on October 25, 1806 and was buried with full military honors.
